1. Introduction

This Bonus Terms and Conditions ("Terms") is entered into by UEXO Global Ltd, a company incorporated in Mauritius with company number 179291, holding an Investment Dealer (Full Service Dealer, excluding underwriting) License issued by the Mauritius Financial Services Commission (FSC) under license number GB21026300, having its registered office at 12th Floor, Hennessy Court, Pope Hennessy Street, Port Louis, Mauritius 72201 ("Company"), and the person or legal entity who has completed the account opening process ("Client").

UXO Services Ltd. is registered in Cyprus with the registration number HE437025 and has its registered address at Archiepiskopou Makariou III, 84, Office 1, 6017, Larnaca, Cyprus. UXO Services Ltd acts as license usage company of UEXO Global Ltd.

2. Table of Definitions

- ★ **Eligible Client** refers to clients who meet the eligibility criteria to participate in the Promotion, as specified in these Terms.
- ★ Eligible Countries/Regions refers to the countries or regions where the Promotion is accessible to clients through their Client Portal, subject to local laws and regulations.
- ★ **Credit Bonus** refers to the bonus funds credited to an Eligible Client's trading account, which cannot be withdrawn but can be used for trading.
- ★ **Deposit Bonus** refers to the bonus amount credited to the Eligible Client's trading account as part of the Promotion, based on qualifying deposits.
- ★ First Time Deposit refers to the initial deposit made by a client, assessed at the user level (not account level), and is considered the client's first-ever deposit with UEXO.
- ★ Trading Account refers to the account held by the Eligible Client with UEXO for the purpose of trading financial products.
- ★ Leverage Ratio refers to the ratio applied to an Eligible Client's trading account that affects the amount of margin required for trading.
- ★ Account Balance reflects your actual deposited funds and realised PnL from trading activities. Profits or losses are directly applied to this balance, while the bonus credit remains unaffected and serves solely as an additional margin for trading purposes.
 - o Formula: Account Balance = Account Equity Credit Bonus Floating PnL.
- ★ **Churning** refers to the practice of opening and closing Margin FX or CFD transactions solely to benefit from promotional offers, rather than executing trades based on sound investment strategies.
- ★ Suspicious Trading Activity refers to any conduct that UEXO, based on reasonable assessment, determines compromises the integrity of its services or markets, including holding opposing positions, exploiting low liquidity or price gaps, or engaging in abusive practices. For details, see the Client Agreement on the website.

3. General Terms And Conditions

- 1. Bonus applies only to valid Standard, PRO, and RAW accounts.
- 2. Clients referred by a PAMM/MAM or money manager or Copy Trading are ineligible to participate in any UEXO offers unless otherwise specified.
- 3. Clients shall not use the credit to engage in Abusive Trading, including (a) opening offsetting positions across multiple accounts under common control; (b) circular/matched trades to generate volume; (c) latency or quote-manipulation. Legitimate hedging within a single account is permitted unless used to manufacture turnover solely to obtain bonus benefits.
 - 3.1. Where abuse is suspected, the Company will conduct a Security Review, notify the Client, and allow 3 Business Days for response before any adverse action.
 - 3.2. Confirmed abuse may result in bonus removal and/or profit adjustment limited to the portion demonstrably derived from abuse, with an evidence summary provided.
- 4. New accounts are subject to UEXO's standard approval processes. Clients are responsible for understanding their local laws and regulations prior to application.
- 5. Clients should ensure that their trading activities align with their individual risk preferences, as this Promotion is not intended to alter the client's risk appetite or trading strategy.
- 6. Clients agree to indemnify and hold UEXO harmless from any claims arising from participation in offers, including violations of terms or applicable laws.
- 7. In the event of any discrepancy between the English version of these Terms and any translated version, the English version shall prevail.

4. Bonus Terms and Conditions

1. Introduction

a. These Terms and Conditions ("Terms") govern the Deposit Bonus Promotion ("Promotion") offered by UEXO Global Ltd ("UEXO" or "the Company"), , a company incorporated in Mauritius with company number 179291, holding an Investment Dealer (Full Service Dealer, excluding underwriting) License issued by the Mauritius Financial Services Commission (FSC) under license number GB21026300, having its registered office at 7th Floor, 51 Rue Du Savoir, Ebene, Cybercity 72201, Mauritius ("Company"). By participating in this Promotion, you acknowledge and agree to comply with these Terms.

2. Eligibility

- a. The Promotion is open to clients who meet the following criteria:
 - Must have a Standard, PRO, or RAW Trading account with UEXO.
 - ii. Bonus is available once per Client (user-level), post-KYC approval.

3. Bonus or Reward Structure

- a. Each promotion that is given by UEXO has their own structure, but most will follow the same formatting.
- b. The total credit amount is capped at a maximum of USD\$10,000 per eligible client at any time.
- c. If any client gets a 100% bonus on their deposit, their IB (if Any) will only get a commission based on the initial deposit.
- d. Here are some examples of how much Credit Bonus the client will receive based on their First-Time Deposit (FTD) amount:

First Time Deposit	Entitlement
\$500	\$500 x 50% = \$250
\$3000	\$3000 x 50% = \$1,500
\$10,000	\$10,000 x 50% = \$5,000
\$20,000	\$20,000 x 50% = \$10,000
\$30,000	Capped at \$10,000

4. Floating Loss

- a. With this Bonus, the company supports Floating Loss.
 - This means that the client can go into negative balance to the value of the bonus.
 - 1. For example, if a client deposits \$100, and receives a 50% bonus worth \$50. This means that the client can go into negative balance up to \$50.

5. **Deposit and Withdrawal Conditions**

- a. The client is eligible for only 1 Credit Bonus with UEXO.
- b. Internal transfers, balance adjustments, cash adjustments, Introducer/Affiliate rebates, or any form of commissions will not be considered as eligible deposits for the purpose of this Promotion.
- c. The credit bonus is non-withdrawable. However, any profits generated from trading using the bonus are eligible for withdrawal, in accordance with the standard withdrawal process. Please note that any losses incurred will be deducted from your account balance, not the bonus credit.
- d. If clients choose to withdraw a portion or the entirety of their deposit and/or profits, the entire credit amount will be deducted from their account accordingly. If clients make an internal balance transfer, the entire credit amount will be deducted from their account. Connecting to a Copy Master Account will result in the entire credit amount to be deducted from the account as well.

6. Disqualification

- a. UEXO reserves the right to disqualify any participant who:
 - i. Violates any of the Terms
 - ii. Engages in abusive trading practices, such as churning; or
 - iii. Provides false information or engages in fraudulent activities.

7. Modification and Termination

a. UEXO reserves the right to amend, suspend, or terminate this Promotion or any of the Terms at its discretion including removing or deducting any credit bonus from a participant account and voiding any profits generated with the use of trading credit. This may occur due to violations of the Terms, suspicious or abusive trading practices or misuse of the credit bonus.

8. Complaints & Escalation

a. Clients may lodge a complaint via support@uexo.com or the Client Portal. The Company acknowledges within 2 Business Days and provides a final response within 15 Business Days (or status update if more time is needed).

9. Local Laws and Jurisdiction

a. This Promotion is subject to the laws and regulations of Mauritius. By participating, you agree that any disputes arising from these Terms will be governed by and resolved under the jurisdiction of the courts of Mauritius.

10. Data Protection and Privacy

a. By participating, you consent to the collection and processing of your personal data in accordance with our Privacy Policy, which is available on our website.

11. Liability

a. UEXO is not liable for any losses, damages, or claims arising from participation in the Promotion. UEXO's liability is limited to the fullest extent permitted by law and will not exceed the total amount of funds deposited by the
